National Americorps program that funds members in full-time positions at health centers to perform a variety of activities associated with health services and programs for patients and the community, often by functioning as community health workers.

Leading software solution for healthcare and community services addressing the social determinants of health. Provides extensive database that allows user to easily identify and access community resources available within certain radius and service's eligibility requirements

and hours of accessibility. Resources updated every 3 – 9 months by team of advocates and navigators. Not free but discounts available for community health centers.

Provides advocates (usually college students) as part of health care team to fill prescriptions for basic resources written by providers. Advocates help connect patients to local community resources while in the clinic waiting room using a resource database and case management system.

MEDICAL-LEGAL PARTNERSHIP TOOLKIT

Developed By: National Center for Medical-Legal Partnership

Embeds lawyers and paralegals alongside health care teams to detect, address, and prevent health-harming social conditions for people and communities. Helps address social determinants of health that can be traced back to laws that are unfairly applied or under-enforced which often leads to the improper denial of services and benefits, including income supports and insurance, housing and utilities, employment and education, legal status, and personal and family stability.
