HRSA's Operational Site Visit (OSV): What You Need to Know to Prepare for and Succeed During Your OSV

Background

The Health Resources and Services Administration's (HRSA) released the most recent version of the [Health Center Program Compliance Manual](#) in August 2018. The Compliance Manual is HRSA's definitive resource for health centers to understand and demonstrate compliance with the Health Center Program Requirements.

HRSA assesses compliance with these program requirements through the Operational Site Visit (OSV). HRSA conducts OSVs with all health centers – whether 330 funded or Look-Alikes – to assess compliance. HRSA's Site Visit Protocol (SVP) is the tool designed for assessing compliance during the OSV. The [SVP was updated by HRSA in April 2019](#).

HRSA recommends that health centers move away from “episodic compliance” and “cramming for the test” to a state of “continuous HRSA compliance.”
