


Representative Kevin Kiley 118th United States Congress

The 4 federally-funded health center organizations with a presence in California's 3rd Congressional District leverage **\$12,726,885** in federal investments to serve **151,841** patients.

Health Center Program Look-Alikes are community-based health care providers that meet the requirements of the HRSA Health Center Program, but do not receive Health Center Program funding. Some locations may overlap due to scale or may otherwise not be visible when mapped. Federal investments represent the total funding from the federal Health Center Program to grantees with a presence in the state in 2021.
