## CALL TO ACTION: Using the Recommended Language for Veteran Status Screening Question

Does your health center ask "Have you Served" to identify Military Veteran status? Evidence shows that the way you ask the question matters. #### **US DEPARTMENT OF VETERANS AFFAIRS (VA)**

- <u>Telehealth</u>: NACHC staff remain in regular contact with the VHA Office of Connected Care and the national program office responsible for its Atlas Telehealth Pilot Project. This project attempts to identify community sites where a Veteran can go for a secure and confidential telehealth visit with a VA provider. Since our last update to you in July, we continue our efforts to identify health centers that have both the capacity to be a "host" site and have a critical mass of VA-enrolled Veterans in their service area. We are seeing progress in health centers getting close to approval as participating sites. - **<u>Rural Health:</u>** NACHC staff are actively engaged with the VHA Office of Rural Health (ORH) and their federal advisory committee. The September meeting of the Veterans Rural Health Committee included a well-received presentation by NACHC's Gina Capra about why and how health centers can be community partners with the VHA's hospitals and clinics. The current membership of this Committee includes several members who are strong advocates for expanding health center and VHA partnerships.
- <u>US Outlying Areas</u>: We are pleased to announce the appointment of Arielle Buyum, Executive Director, Pacific Islands Primary Care Association (PCA) to the newly established federal advisory committee on the US Outlying Areas and Freely Associated States. The Committee will provide advice and guidance to the Secretary of Veteran Affairs on matters related to Veterans residing in American Samoa, Guam, Puerto Rico, the Commonwealth of the Northern Mariana Islands, the Virgin



Islands, the Federated States of Micronesia, the Republic of Marshal Islands and the Republic of Palau.
