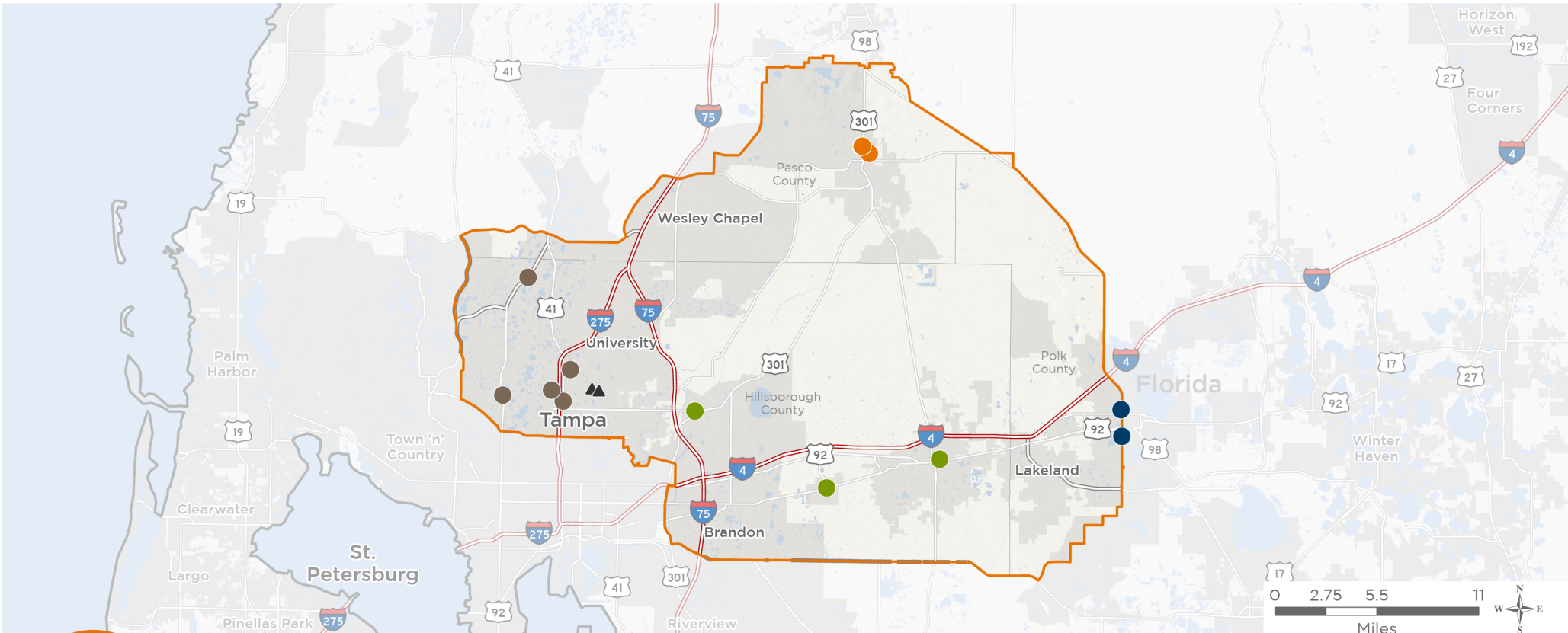




The 4 federally-funded health center organizations with a presence in Florida's 15th Congressional District leverage **\$33,140,029** in federal investments to serve **297,238** patients.
